



## PROGRAM PARTICIPANT WAIVER

### **PROGRAM PARTICIPATION STATEMENTS**

#### **WAIVER**

The undersigned agrees that the City of Davenport and its representatives, successors, and assigns shall not be held liable for any illness or injury or damage to person or property resulting from participation in a Parks and Recreation program or activity. The undersigned recognizes and acknowledges that there are certain risks of physical injury to participants in these programs/activities, and the undersigned voluntarily agrees to assume the full risk of any and all injuries, damages or loss, regardless of severity, that his/her minor child/ward or he/she may sustain as a result of said participation. The undersigned further agrees to waive and relinquish all claims he/she or their minor child/ward may have or accrue as a result of participating in these programs/activities against the City of Davenport and its representatives, successors and assigns. The undersigned hereby fully releases and forever discharges the City of Davenport from any and all claims for injuries, damages, or loss that their minor child/ward or his/her may have or which may accrue to them or their minor child/ward and arising out of, connected with, or in any way associated with these programs/activities.

By registering in a Parks and Recreation program, each registrant consents to the free and unrestricted use of their name and/or likeness (including photographs, videos and other depictions) by the Parks and Recreation Department.

#### **PAYMENT**

If I am paying by credit card, I authorize Davenport Parks and Recreation to charge the appropriate fee to the credit card number I supply.

#### **REFUND POLICY**

A request for a refund due to withdrawal from a program must be made to the administrative office prior to the 2<sup>ND</sup> class meeting. All approved refunds will be charged a \$25 processing fee. Requests for refunds after the 2<sup>ND</sup> class meeting will be charged a prorated amount for classes already attended and \$10 processing fee. If a class is cancelled by Parks and Recreation, a full refund will be issued. All refunds will be paid by city check; no cash refunds.

#### **PROGRAM MAKE-UP**

If a program meeting(s) is missed due to reasons beyond the control of Parks and Recreation (i.e., weather, power outages, etc.), the program meeting may not be rescheduled. If program meets multiple times, we may not be able to make-up the date missed.

Finally, we never use or share the personally identifiable information provided to us online in ways unrelated to the ones described above without also providing you an opportunity to opt-out or otherwise prohibit such unrelated uses.
